A purchase of a TELEX Airman 7 (Double Sided Headphone Airman 7-0000 is excluded from this action) or a TELEX Airman 8 during the promotion time frame defined in paragraph 2 is necessary to enter the Promotion. To enter the Promotion, entrants must register the referring action code as well as their details (full name, postal address, country, phone number, e-mail address) via www.promo-telex.com. Entrants have to provide details about their purchase (type, date, country of purchase) and provide accounting details to realize bank transfer. A proof of purchase by sending in a scan of the original invoice issued by an official dealer or reseller is mandatory. Invoices in the course of a private sale are not accepted.
